 - Organize a search and rescue team or act as liaison for Department of Public
 - Safety in the community.
 - Train SAR team members.
 - Maintain a list of available SAR equipment and supplies on hand.
 - Coordinate SAR's with the assistance of the Alaska State Troopers.
- 4. General Public Safety
 - Assist health aides in emergency situations.
 - Provide public safety information to schools and the public.
 - Provide dog control and vaccinate for rabies when trained to do so.
 - · Conduct water and snow machine safety.
- 5. Probation/Parole Monitoring
 - VPSO's will document personal contact with specified probationers and parolees at least twice per month, or as requested by the Supervisor of the District Probation Office for the Department of Corrections.

DISCRIPTION: The VPSO, works along with the oversite of the Public Safety Director, VPSO Coordinator and the Alaska State Troopers (AST) to ensure deliver of community law enforcement, probation and parole supervision, and public safety services within the Northwest Arctic Borough (NAB). Village Public Safety Officers (VPSO'S) are dedicated employees living in rural Alaska who assists their community in all aspects of public safety to include search & rescue, fire protection, emergency medical assistance, and especially law enforcement. Service coordination is provided with the cooperation of the city council or local tribal governments.

 - Conduct boat, ATV and snow machine safety training

- Emergency Management:
 - Serve as a liaison for emergency preparedness and response, assists the NAB Public Safety Department
 - Provide input on the community's Emergency Operations Plan
 - Assist with the coordination of any emergency related training (e.g., Incident Command System, Emergency Trauma Technician, etc.)
- Travel as required from village based-work location
